

# HORIZONS ETFS ANNOUNCES OCTOBER 2018 DISTRIBUTIONS FOR ITS COVERED CALL ETFs

**TORONTO – October 24, 2018** – Horizons ETFs Management (Canada) Inc. ("**Horizons ETFs**") is pleased to announce the distribution amounts per unit (the "**Distributions**") for its suite of covered call exchange traded funds (the "**ETFs**"), for the period ending October 31, 2018, as indicated in the table below.

The ex-dividend date for the Distributions is anticipated to be October 30, 2018, for all unitholders of record on October 31, 2018. The Distributions for units of each ETF will be paid in cash or, if the unitholder has enrolled in the respective ETF's dividend reinvestment plan ("**DRIP**"), reinvested in additional units of the applicable ETF, on or about November 13, 2018.

Distribution rates are generally based on the average current volatility of the securities held by the ETF, along with any dividend income received, less expenses payable by the ETF. Monthly distributions will be paid in cash, unless the investor has chosen to participate in the ETF's reinvestment plan.
