In all other respects, the disclosure in the Prospectus is not revised. All capitalized terms not defined in this amendment no. 2 have the respective meanings set out in the Prospectus

Change to the Names of the ETFs

As announced on April 18, 2024, effective May 1, 2024, the names of the ETFs have been changed as follows:

The names of the ETFs have been changed in connection with a rebranding announced by the Manager on March 6, 2024.

Change to the Name of the Manager

As announced on March 6, 2024, effective May 1, 2024 the name of the Manager and Investment Manager of the ETFs has been changed from Horizons ETFs Management (Canada) Inc. to Global X Investments Canada Inc.

Change to the Name of the Company

In accordance with the rebranding announced by the Manager on March 6, 2024, the name of the Company, of which each ETF is a separate Corporate Class, has been changed from Horizons ETF Corp. to Global X Canada ETF Corp., effective May 1, 2024.

PURCHASERS' STATUTORY RIGHTS OF WITHDRAWAL AND RESCISSION
