



Proxy Vote Summary

Global X Enhanced All-Equity Asset Allocation ETF (HEQL)

The Global X Enhanced All-Equity Asset Allocation ETF has primarily, if not all, held units of one or more exchange traded funds (“the underlying ETF funds”) for the period from July 1, 2024 to June 30, 2025. Unlike companies, exchange traded funds do not have annual shareholder meetings, but they may hold unitholder meetings from time to time, at which unitholders of the underlying ETF funds are entitled to exercise voting rights. In the event that any of the underlying ETF funds issues a proxy form, Global X Investments Canada Inc. will exercise those voting rights in the best interests of Global X Enhanced All-Equity Asset Allocation ETF in accordance with applicable law. Furthermore, the manner in which the voting rights were exercised will be published on this page.
