Definitions:

Average Coverage - The average percentage of the Fund's assets for which options are written, calculated daily.

Average Moneyness - The portfolio's weighted average percentage of the options' strike price relative to the underlying asset's spot price, at time of writing.

Average Annualized Option Yield - The annualized portfolio's weighted average* option yield, based on trades completed during the month.

Dividend Yield - The portfolio's weighted average* annualized dividend yield of the underlying assets.

Indicative Yield - Sum of the average* annualized option yield & dividend yield, estimating the yield generated by the Fund.

Duration - Is a measure of the Fund's sensitivity to changes in interest rates, calculated as of the last business day of the month according to the portfolio construction methodology.

Yield-to-Maturity - The portfolio's weighted average yield-to-maturity of the underlying assets, calculated as of the last business day of the month.
