### Definitions:

**Average Coverage** - The average percentage of the Fund's assets for which options are written, calculated daily.

**Average Moneyness** - The portfolio's weighted average percentage of the options' strike price relative to the underlying asset's spot price, at time of writing.

**Average Annualized Option Yield** - The annualized portfolio's weighted average\* option yield, based on trades completed during the month.

**Dividend Yield** - The portfolio's weighted average\* annualized dividend yield of the underlying assets.

**Indicative Yield** - Sum of the average\* annualized option yield & dividend yield, estimating the yield generated by the Fund.

**Duration** - Is a measure of the Fund's sensitivity to changes in interest rates, calculated as of the last business day of the month according to the portfolio construction methodology.

**Yield-to-Maturity** - The portfolio's weighted average yield-to-maturity of the underlying assets, calculated as of the last business day of the month.
